

NOTICE OF AMENDMENT TO FY 2008 ANNUAL ACTION PLAN

The notice is hereby given by the City of Pittsburgh, PA that it is amending its FY 2008 Consolidated Annual Action Plan. The City intends to submit its Amended FY 2008 Consolidated Annual Action Plan in the amount of \$4,478,251 for Community Development Block Grant Recovery (CDBG-R) funds to the U.S. Department of HUD on or before June 5, 2009. In order to receive those funds, the City of Pittsburgh must prepare a substantial amendment to its FY 2008 Consolidated Annual Action Plan.

The City of Pittsburgh proposes the following amendment to its FY 2008 plan year:
